A1: 1,600

Q2: How many EAP sessions per person per issue would you like quoted? A2: Quote 6 sessions (3 per 6-month period) and 5 sessions per incident

Q3: Who is your current EAP provider?

A3: Integrated Behavioral Health

Q4: What is your current PEPM rate?

A4: \$1.55 PEPM

Q5: What services are included in this rate (# of sessions, work/life, onsite hours, etc.)?

A5: 6 sessions (3 per 6-month period), legal, financial, childcare, elder care, supervisor support

Q6: How many years have you been with the current EAP provider?

A6: Since 2011
