Yes, provide the electronic copy of the proposal fee as a separate file.

Can documents that must be sign/notarized be scanned in and emailed? if the sign/notarized documents may be scanned can they be a separate pdf document or must they be placed at the front of the proposal pdf? Pages 24-26 submission – can these be a separate pdf?

Original must be submitted with signed and notarized documents. The six (6) copies may be scans of the original. Please submit scanned copies as PDF format for the USB or email version.

On page 3, section 1.2 of the RFP "Invitation to Submit a Proposal" the RFP indicates that 1 original and 6 copies shall be submitted, as well as one electronic version. Later in the same section, it says "proposals may also be submitted electronically to." To clarify, can proposals be submitted electronically in lieu of submitting the 7 hard copies, or would the electronic submission be in addition to the hard copy submissions.

No, please submit one original and six copies as hard documents. An electronic version must be submitted in addition to the hard copies via USB or email.
