**THE CITY'S RESPONSES TO QUESTIONS SUBMITTED ARE IN BLUE**

Questions:

1. How much notice is given to respond to each vessel removal?

Notification to remove vessel will be based on public safety and environmental sensitivity. Reaction time of the contractor will be important and may vary on a case by case basis.

2. With each vessel removal request, are we correct to assume that details of the vessel and location will be provided prior to a scope/cost be given to the City?

Any known information/details regarding the vessel and its location will be disclosed to the contractor(s) upon notification of service need.

3. Are we required to use Long Shoremen and/or union workers?

The City does not require Long Shoremen or Union Workers. However, the City will require the contractor(s) to comply with all California Department of Industrial Relations requirements (prevailing wage requirements) and City of Stockton Municipal Code (SMC) Section 3.68.095 Ordinance No. 011-09 adopted September 1, 2009, effective October 1, 2009.

4. In light of COVID-19, can this be an e-signature?

For the purpose of submitting a bid proposal electronic signatures are allowed.

5. How would I go about requesting information on the incumbent's past submittal as it pertains to your Bid No PUR 20-035; City of Stockton Removal and Disposal of Derelict Vessels?

The City of Stockton does not have any past submittals.
