## NOTICE INVITING PROPOSALS

NOTICE IS HEREBY GIVEN that sealed proposals will be received no later than **Thursday, NOVEMBER 18, 2021, at 2:00 pm (local time)** by the City of Stockton, California for a HOMELESS SYSTEM SUPPORT – PUR 21-032 in strict accordance with the specifications.

The City of Stockton, hereinafter referred to as the “City”, is requesting proposals (RFP) from firms or individuals, hereinafter referred to as “Proponent,” to provide consulting services to the City. As part of the American Rescue Plan Act (ARPA) of 2021, the City anticipates receiving approximately \$78 million in additional funding to address local needs generated by the COVID-19 pandemic. The portion of funding that is scheduled to award for homelessness and housing initiatives is up to \$12 million. The City currently has \$5 million and anticipates receiving the remaining funds in the June 2022. Because these funds will be received directly from the U.S. Treasury, the City is seeking experienced, professional services to augment staff’s capabilities to ensure compliance with federal regulations while maximizing the recovery and beneficial uses of the ARPA funds in the local community.

The City is undertaking several homelessness initiatives, consisting of demonstration projects, policy analysis and development, collaboration, to produce three (3) major deliverables: 1) project management of demonstration projects; 2) development of departmental homeless policy and program guidelines; and 3) build the foundation for city wide homeless stat process, including appropriate metrics.

Each sealed proposal shall be marked "PROPOSAL" and shall indicate the project name, number, and proposal opening date, and shall be mailed or delivered to the address below at or before the hour stated. Each Proponent must be licensed in accordance with applicable California State Law.

# 1.0 BACKGROUND/SUMMARY

The City of Stockton, hereinafter referred to as the “City”, is requesting proposals (RFP) from firms or individuals, hereinafter referred to as “Proponent,” to provide consulting services to the City. As part of the American Rescue Plan Act (ARPA) of 2021, the City anticipates receiving approximately \$78 million in additional funding to address local needs generated by the COVID-19 pandemic. The portion of funding that is scheduled to award for homelessness and housing initiatives is up to \$12 million. The City currently has \$5 million and anticipates receiving the remaining funds in June 2022. Because these funds will be received directly from the U.S. Treasury, the City is seeking experienced, professional services to augment staff’s capabilities to ensure compliance with federal regulations while maximizing the recovery and beneficial uses of the ARPA funds in the local community.

The City is undertaking several homelessness initiatives, consisting of demonstration projects, policy analysis and development, collaboration, to produce three major deliverables: 1) project management of demonstration projects; 2) development of departmental homeless policy and program guidelines; and 3) build the foundation for city wide homeless stat process, including appropriate metrics. This effort will build upon the foundation of homeless response within the City and will incorporate existing efforts to build transparency by supplying the accurate data for the cities open data portal.

# 2.0 SCOPE OF SERVICES

Proponent shall provide analysis and project oversight for several American Plan Rescue Act (ARPA) funded initiatives; research, analyze and create a set of comprehensive departmental homeless policies; build infrastructure for accurate collection of data from multiple entities and foster collaboration at all levels.

## 2.1 TASK 1: Demonstration Project Oversight

- 2.1.1 Create RFP scope of work for wrap-around services for the Safe Parking Site Demonstration Program and the Low Barrier Shelter Bed initiatives.
- 2.1.2 Work collaboratively with Public Works, Police Department, and Fire Department to implement all necessary requirements for the Safe Parking Site Demonstration Program.
- 2.1.3 Monitor selected contractor for the Safe Parking Site Demonstration Program and Low Barrier Shelter Bed initiative including contract compliance, reporting (both HMIS and ARPA) and quality assurance.
- 2.1.4 Ensure all efforts meet ARPA compliance; collect, prepare, and submit accurate reports to City staff to meet ARPA reporting deadlines.
- 2.1.5 Provide research and write RFPs for up to three additional ARPA initiatives.
- 2.1.6 Develop contract and work with selected entities to create complete scopes of work with metrics for all RFPs mentioned above.

## **2.2 TASK 2: Homeless Policy Analysis and Development**

Building departmental homeless policy program guidelines will provide clarity and understanding between City Departments, residents and entities who serve homeless. A review of Departmental polices regarding homeless funding best practices, contract compliance and analysis of current and forthcoming grant opportunities would enable the City to better serve the homeless population during COVID.

The proponent shall accomplish the following:

- 2.2.1 Review and analyze Economic Development Departments current existing homeless policies and program guidelines and make recommendations for improvement.
- 2.2.2 Analyze intersectionality of City departments housing, fire and police policies and practices and provide recommendations.
- 2.2.3 Research best practices and make recommendations for program guidelines and implementation of above-mentioned programs.
- 2.2.4 Prepare staff reports and presentations.
- 2.2.5 Identify potential policy or program implementation conflicts with County, State and Federal regulations and propose potential solutions as it pertains to the above-mentioned programs.
- 2.2.6 Provide departmental-level analysis of pending homeless legislation and potential impacts of the legislation to the City.
- 2.2.7 Convene and manage a productive internal homeless response taskforce.

## **2.3 TASK 3: Build and Track Metrics**

The City has created an Office of Performance and Data Analytics (ODPA) and an Open Data Portal with the goal of tracking progress toward goals and providing transparency. This task includes building the necessary internal and external infrastructure to accurately collect data, serve as the main contact for OPDA and create a homeless stat process

The proponent shall accomplish the following tasks:

- 2.3.1 Serve as staff liaison to ODPA for the development of Homeless stat process. Provide necessary data and analysis for bi-weekly reports and coordinate with staff that serve on stat panel.
- 2.3.2 Provide monthly homeless data scorecard to ODPA
- 2.3.3 Attend local and regional meetings that address homelessness including but not limited to Continuum of Care to understand regional impacts on success and gain necessary data.
- 2.3.4 Prepare quarterly and annual updates on progress toward goals.
- 2.3.5 Serve as City liaison with contracted agencies working to implement a Coordinated Entry System ensuring contract compliance, effectiveness and success.

**2.4 TASK 4: On-demand Consulting Services**

Given the rapidly changing environment regarding COVID response and the lasting impacts on homelessness it is anticipated that additional projects and services will be required. An individual, or a consistent individual at a firm, should generally be substantially available to work on City projects and be present on site as required.

**Cost Range**

ARPA funds up to \$540,000 have been allocated for homeless staff augmentation purposes.

**4.0 SUBMITTAL REQUIREMENTS**

**Minimum Qualifications**

1. Two years’ experience of proponent individual or team working together with governmental agencies on projects of a similar or related nature.
2. Experience in preparation of homeless policies and/or program implementation guidelines that are clear, concise, legally defensible, and which reflect the needs of the community.



3. Experience and knowledge of local homeless initiatives, Continuums of Care, American Rescue Plan Act funding guidelines and homeless general best practices.
4. Familiarity with local, State and Federal response to homeless initiatives during COVID pandemic; including State response such as Project Homekey, Project Roomkey, Emergency Rental Assistance Program, County Public Health and nonprofit health and shelter response.
5. An understanding of the role of behavioral health, social services and governmental housing programs and policies play in the success of homeless initiatives and demonstrated ability to successfully navigate the complexities.
6. Any other information that would assist the review team in understanding the consultant team's capacity to efficiently and effectively complete the project.

#### 4.1 PROPOSAL GUIDELINES, CONTENT AND FORMAT

The City of Stockton uses a qualifications-based selection process in obtaining these services. In order for the City to properly evaluate the Proponents' qualification to perform this work, the proposals shall include, as a minimum, the following information:

- A. Evidence of the Proponent's ability to be responsive to this project in regard to timeliness and expertise, including availability of an individual or staff proposed to be assigned.
- B. The Proponents are encouraged to expand on the Scope of Work to demonstrate their expertise. Evaluation of the proposals will be based on qualifications, the experience of the individual or staff proposed to be assigned to the project, references and thoroughness of the Proponent's response to the Scope of Services.
- C. Such additional information that the Proponent may feel would be pertinent to assist the City of Stockton in making its final decision.
- D. Please submit one (1) original and four (4) copies of your proposal/qualifications. Additionally, submit one (1) USB with an electronic version of the proposal. The original should be unbound to allow us to reproduce your proposal, as needed.
- E. The proposal must be submitted, typewritten on 8½" X 11" white paper and must be bound in a secure manner.
- F. Material and data not specifically requested for consideration, but which the Proponent wishes to submit must not appear with the Proposal but may appear only in an "Additional Data" section. This has specific reference to the following types of data: Generalized narrative of supplementary information; and Supplementary graphic material.
- G. All proposals must be signed with the full name of the Proponent, if an individual; by an authorized general partner, if a partnership; or by an authorized officer, if a corporation.
- H. When proposals are signed by an agent other than an officer of a corporation or a member of a general partnership, a power of attorney authorizing the signature must be submitted with the proposal.
- I. If the proposal is submitted by a partnership or joint venture, the Statement of Personal History attached to the Proposal must be completed by each general partner or joint venture thereof. If

the proposal is submitted by a corporation, the Statement must be completed by each principal officer of said corporation.

- J. The original proposal must have wet ink signatures. Modification to a proposal after the proposal submittal deadline will not be accepted by the City.

#### 4.2 COVER LETTER

Submit a letter on your company letterhead addressing the proposal and format. The letter should be signed by an officer of the firm authorized to bind the firm to all comments made in the proposal, and shall include the name, address, phone number and e-mail address of the person(s) to contact who will be authorized to represent your firm.

In no more than three (3) pages, the Cover Letter and Executive Summary shall include:

- A. The names of the key members of the consultant team;
- B. The mailing address, telephone number, and the name of the main point of contact for the consultant team;
- C. A summary of the consultant's electric-arc hazard assessment experience and qualifications and the significant advantages to selecting the consultant;
- D. An acknowledgement of receiving any addendum(s) to the RFP document.

#### 4.3 REFERENCES

Provide a list of references with current contact person, e-mail address and phone number who may be contacted regarding firm performance.

The review team will conduct a background reference review of each respondent. Please include the following information for three (3) projects that the proposed consultant team worked on together:

- A. Name of the Client/Project/Study
- B. Location of the Project
- C. Name, title, and contact information for the client
- D. Project Budget
- E. Date of Completion of the Project

#### 4.4 FINANCIAL STATEMENT

The Proponent must be able to demonstrate a good record of performance and have sufficient financial resources to ensure that they can satisfactorily provide the services required herein.

Proponent shall submit a full and detailed presentation of the true condition of the Proponent's assets, liabilities and net worth. The report should include a balance sheet and income statement. If the Proponent is a new partnership or joint venture, individual financial statements must be submitted for each general partner or joint venture thereof. If firm is a publicly held corporation, the most current annual report should be submitted.

Any Proponent who, at the time of submission, is involved in an ongoing bankruptcy as a debtor, or in a reorganization, liquidation, or dissolution proceeding, or if a trustee or receiver has been appointed over all or a substantial portion of the property of the Proponent under federal bankruptcy law or any state insolvency, may be declared non-responsive.

#### 4.5 CORPORATE STRUCTURE, ORGANIZATION

Describe how your firm is organized, noting major divisions and any parent/holding companies, as well as brief history of the firm and all personnel potentially to be involved in the project including all sub-consultants. Designate the Principal in Charge and other key personnel. Include résumés. Also provide a description of the experience your firm has had with similar processes.

#### 4.6 PROPOSAL FEE

Submit the proposal fee under sealed, separate envelope. Do not include with the technical proposal response. Provide hourly rates for each type of activity and each level of personnel, as well as an estimated total to complete the scope of work. Provide detailed basic fee structure and break-down of any other charges related to your firm's proposal as specified. Finalist's fee structure may be subject to negotiation.

### 5.0 SELECTION CRITERIA & EVALUATION

The City is interested in selecting a qualified firm with the ability to provide Homeless System Support. A key component for the successful firm will be the ability to meet the performance desires of the City while minimizing the cost.

The Evaluation Panel will consist of City of Stockton staff and any other person(s) designated by the City. Following review of the proposals, the Panel may invite one or more Proponents to make an oral presentation. During these presentations, the Proponent will be allowed to present such information as may be appropriate in order that the Panel can effectively and objectively analyze all materials and documentation submitted as part of the proposals.

Each firm must be represented by an individual who will be the prime contact person to the City and any other individuals whom the firm may select. The highest-rated proposal(s) will then be further scrutinized through financial analysis and reference checks.

Proposals shall be evaluated according to; demonstrated understanding of tasks required, technical approach to specified operations, qualifications of staff, experience of company, demonstrated knowledge of best practices for identified scope, financial business strength and fee schedule proposal. Proper format and demonstrated experience will merit consideration.

To that end, the Panel will evaluate the proposals based on, but not limited to, the following criteria:

1. Proponent's approach and schedule to provide all services as outlined in the Scope of Services and related documents;
2. Related experience with similar projects, company background and personnel qualifications;
3. Proponent's Fee Schedule - completed and signed under separate, sealed cover;
4. Proponent's Agreement;
5. Non-Collusion Affidavit;
6. References;
7. Financials Review;
8. Interview/Presentation, if applicable; and
9. Any other criteria as best suits the City of Stockton.

1) Qualifications of the organization, overall experience, recent public sector experience conducting similar work	30%
2) Approach and strategic fit consistent with the objectives of the City of Stockton	20%
3) Cost associated with proposed plan (retainer or hourly fee)	20%
4) References/Industry Reputation	20%
5) Quality and clarity of proposal	10%

## 6.0 CITY REQUIREMENTS

### 6.1 CITY RESPONSIBILITIES

City will provide all readily available policies, documentation, and data necessary for completing the above tasks. Given the need to have an individual substantially available the City will provide office space if necessary.

Staff will be available as needed and will assist with coordination of meetings.

### 6.2 LOCAL BUSINESS PREFERENCE

Stockton Municipal Code Section 3.68.090 reads as follows:

Preference shall be given to the purchase of supplies, materials, equipment, and contractual services from local merchants, quality and price being equal. Local merchants who have a physical business location within the boundaries of San Joaquin County, and who have applied for and paid a business license tax and registration fee pursuant to Stockton Municipal Code Title 5, Chapter 5.08, License Taxes, shall be granted two (2) percent bid preference. Local merchants who have a physical business location within the boundaries of the City of Stockton, and who have applied for and paid a business license tax and registration fee pursuant to Stockton Municipal Code Title 5, Chapter 5.08, License Taxes, shall be granted five (5) percent bid preference. This section is intended to provide preference in the award of certain City contracts in order to encourage businesses to move into and expand within the City. (Ord. 2014-03-18-1601 C.S. § 1; prior code § 3-106.1)

### 6.3 TERM

From execution date to on or before December 31, 2024. Option to renew or extend for additional term pending funding.

#### 6.4 OTHER GOVERNMENT AGENCIES

If mutually agreeable to all parties, the use of any resultant contract/purchase order may be extended to other political subdivisions, municipalities, or tax supported agencies.

Such participating governmental bodies shall make purchases in their own name, make payment directly to successful Proponent and be liable directly to the successful Proponent, holding the City of Stockton harmless.

#### 6.5 INSURANCE REQUIREMENTS

Proponent/Bidder, at Proponent's/Bidder's sole cost and expense and for the full term of the resultant contract or any extension thereof, shall obtain and maintain at least all of the insurance requirements listed in attached Exhibit B.

All coverage shall be provided by a carrier authorized to transact business in California and shall be primary. All policies, endorsements, and certificates shall be subject to approval by the Risk Manager of the City of Stockton as to form and content. These requirements are subject to amendment or waiver if so, approved in writing by the Risk Manager.

Maintenance of proper insurance coverage is a material element of this contract, and failure to maintain or renew coverage or to provide evidence of renewal may be treated as a material breach of contract.

The Proponent shall assert that these insurance requirements will be met as part of their proposal response. Failure to comply with these insurance requirements may result in a proposal being deemed unresponsive. Proponent shall satisfy these insurance requirements concurrently with the signing of the contract prior to commencement of work. It is strongly suggested that insurance requirements be reviewed with Proponent's broker to ensure any additional costs are included in the proposal pricing component.

#### 6.6 APPLICABLE LAW

Applicable law shall be governed by the laws of the State of California. Venue shall be proper in the Superior Court of the State of California, County of San Joaquin, Stockton Branch, or, for actions brought in Federal Court, the United States District Court for the Eastern District of California, Sacramento Division.

#### 6.7 METHOD OF PAYMENT

Payment will be made within thirty (30) days after invoices are received and accepted by the City Manager. Invoices are to be rendered monthly, unless prescribed differently per contract.

#### 6.8 NOTICE TO OUT OF STATE BUSINESS

It is the policy of the City of Stockton to pay all applicable California sales/use tax directly to the State Board of Equalization (BOE) pursuant to California Revenue and Taxation Code 7051.3. The City of Stockton will self-accrue all sales/use tax on purchases made from out-of-state business,

unless documentation is provided by Proponent evidencing the business is registered with the state of California.

Sales and use tax on purchases made by the City of Stockton from all companies located outside California, not registered with the state and whose products are shipped from out of state will be remitted to the BOE directly by the City under permit number SR KHE 28-051174 DP. Please do not include sales/use tax on the invoice that you submit to the City of Stockton.

Questions regarding the City of Stockton's payment of sales/use tax can be directed to the City of Stockton's Procurement Division at (209) 937-8357.

## 6.9 CONFIDENTIALITY

If Proponent believes that portions of a proposal constitute trade secrets or confidential commercial, financial, geological, or geophysical data, then the Proponent must so specify by, at a minimum, stamping in bold red letters the term "CONFIDENTIAL" on that part of the proposal which the Proponent believes to be protected from disclosure. The Proponent must submit in writing specific detailed reasons, including any relevant legal authority, stating why the Proponent believes the material to be confidential or a trade secret. Vague and general claims as to confidentiality will not be accepted. The City will be the sole judge as to whether a claim is general and/or vague in nature. All offers and parts of offers that are not marked as confidential may be automatically considered public information after the contract is awarded. The Proponent is hereby put on notice that the City may consider all or parts of the offer public information under applicable law even though marked confidential.

## 6.10 PROTEST POLICY

Protest and Appeal Procedures. In order to maintain fairness and impartiality, the City of Stockton has established a solicitation protest policy and procedure.

### 6.11.A Protest Procedure

- 6.10.1 All protests must be in writing and stated as a formal protest.
- 6.10.2 A casual inquiry, complaint, or a statement of intent to protest that does not provide the facts and issues and does not comply with the content requirements or deadlines, will not be considered or acted upon as a protest.
- 6.10.3 The protest must contain a complete statement of the basis for the protest and must include all relevant supporting documentation.
- 6.10.4 The solicitation process and procedures, including evaluation criteria, shall not be proper grounds for protest. Concerns related to the solicitation process and procedures, including evaluation criteria, should be raised and addressed, if at all, prior to the bid/proposal due date and time to allow adjustments before evaluation of the solicitation.
- 6.10.5 Protests must be filed with the City's Chief Financial Officer, or designee, at the address listed in the Solicitation Protest FAQ sheet and Procurement Procedure Manual, not later than five (5) days after the date the City mails the Letter of Intent to Award.
- 6.10.6 Deliveries of the protest by hand, mail, email or fax are acceptable.

- 6.10.7 The City is not responsible for lost or misplaced protests, or to assure the protest is received within the protest deadlines
- 6.10.8 The party challenging the award decision to bear the burden of proof of material error to justify invalidation of the proposed award.

6.11.B Protest Review

- 6.10.9 The Chief Financial Officer or designee shall respond in writing at least generally to each material issue raised in the protest.
- 6.10.10 The Chief Financial Officer's, or designee 's, administrative decision may be appealed in writing to the City Manager no later than (5) business days after the date the Chief Financial Officer's, or designee's, the decision is mailed to the protesting party.
- 6.10.11 The City Manager shall review and decide the appeal based on the grounds and documentation set forth in the original protest to the Chief Financial Officer, or designee.
- 6.10.12 Each party shall bear its own costs and expenses involved in the protest and appeal process, including any subsequent litigation.
- 6.10.13 The City Manager's administrative decision is final. After the City Manager issues the final administrative decision, the time in which judicial review of the decision must be sought shall be governed by California Code of Civil Procedure Section 1094 or as such section may be amended from time to time.
- 6.10.14 If the protested procurement involves state or federal funds, the Chief Financial Officer, or designee, shall give notice to the interested party that he or she has the right to appeal to the appropriate agency, which shall be identified by name and address. An appeal hereunder shall be filed with the appropriate agency within five (5) working days of the dispatch of rejection notices to the interested party(ies).
- 6.10.15 The City may require the protesting party to submit a City Council approved non-refundable protest fee to cover the administrative cost of processing the protest.

Bidders, Proponents, and contractors wishing to protest or appeal a procurement or contracting decision by the City must follow the procedures provided by this section. The City will not review protests or appeals that are not submitted in accordance with these provisions and procedures.

## 7.0 GENERAL REQUIREMENTS, TERMS & CONDITIONS

### 7.1 CONSEQUENCE OF PROPOSAL SUBMISSION

- A. The City shall not be obligated to respond to any proposal submitted nor be legally bound in any manner by the submission of a proposal.
- B. Acceptance by the City of a proposal obligates the Proponent to enter into an agreement with the City.

- C. An agreement shall not be binding or valid against the City unless or until it is executed by the City and the Proponent.
- D. Statistical information contained in these documents is for informational purposes only. The City shall not be responsible for the accuracy of said data. City reserves the right to increase or decrease the project scope.

## 7.2 ACCEPTANCE OR REJECTION OF PROPOSAL

A proposal shall be prepared and submitted in accordance with the provisions of these RFP instructions and specifications. Any alteration, omission, addition, variance, or limitation of, from, or to a proposal may be sufficient grounds for rejection of the proposal. The City has the right to waive any defects in a proposal if the City chooses to do so. The City may not accept a proposal if any document or item necessary for the proper evaluation of the proposal is incomplete, improperly executed, indefinite, ambiguous, or missing.

The City reserves the right to select the successful proposal and negotiate an agreement as to the scope of services, the schedule for performance and duration of the services with Proponent whose proposal is most responsive to the needs of the City. Further, the City reserves the right to reject any and all proposals, or alternate proposals, or waive any informality or irregularity in the proposal as is in the City's best interest.

The City reserves the right to reject any and all proposals, or portions thereof, received in response to the RFP or to negotiate separately with any source whatsoever, in any manner necessary, to serve the best interests of the City. Additionally, the City may, for any reason, decide not to award an agreement as a result of this RFP.

Non-acceptance of any proposal shall not imply that the proposal was deficient. Rather, non-acceptance of any proposal will mean that another proposal was deemed to be more advantageous to the City or that the City decided not to award an agreement as a result of this RFP.

## 7.3 RIGHT TO CHANGE OR AMEND REQUEST

The City reserves the right to change the terms and conditions of this RFP. The City will notify potential Proponent of any material changes by posting on the City's website. No one is authorized to amend any of the RFP requirements in any respect, by an oral statement, or to make any representation or interpretation in conflict with its provisions. If necessary, supplementary information and/or clarifications/questions/answers will be posted on the City's website at [www.stocktonca.gov/adminbid](http://www.stocktonca.gov/adminbid). Failure of any Proponent to not have received such information and/or clarifications/questions/answers shall not relieve such Proponent from any obligation under his/her proposal as submitted.

Any exceptions to this Proposal shall be clearly stated in writing.

## 7.4 CANCELLATION

The City reserves the right to rescind award of the contract at any time before execution of the contract by both parties if rescission is deemed to be in City's best interest. In no event shall City have any liability for the rescission of award. The Proponent assumes the sole risk and responsibility for all expenses connected with the preparation of its proposal.



## 7.5 EXAMINATION OF PROPOSAL MATERIALS

The submission of a proposal shall be deemed a representation and warranty by the Proponent that it has investigated all aspects of the RFP, that it is aware of the applicable facts pertaining to the RFP process and its procedures and requirements, and that it has read and understands the RFP. No request for modification of the provisions of the proposal shall be considered after its submission on the grounds the Proponent was not fully informed as to any fact or condition. Statistical information which may be contained in the RFP or any addendum is for informational purposes only. The City disclaims any responsibility for this information which may subsequently be determined to be incomplete or inaccurate.

## 7.6 ADDENDA AND INTERPRETATION

The City will not be responsible for, nor be bound by, any oral instructions, interpretations, or explanations issued by the City or its representatives. Any request for clarifications, questions, or answers of this RFP shall be made in writing/e-mail and deliverable to:

The Proponent should await responses to inquiries prior to submitting a proposal.

## 7.7 DISQUALIFICATION

- a. Any of the following may be considered cause to disqualify a Proponent without further consideration:
- b. Evidence of collusion among Proponents;
- c. Any attempt to improperly influence any member of the evaluation panel;
- d. Any attempt to communicate in any manner with a City of Stockton elected official during the RFP process will, and shall be, just cause for disqualification/rejection of Proponent's proposal/Proponent's bid submittal and considered non-responsive.
- e. A Proponent's default in any operation of a professional services agreement which resulted in termination of that agreement; and/or
- f. Existence of any lawsuit, unresolved contractual claim, or dispute between Proponent and the City.
- g. No person, firm, or corporation shall be allowed to make or file or be interested in more than one bid for the same supplies, services, or both; provided, however, that subcontract bids to the principal bidders are excluded from the requirements of this section: Section 3.68.120 of the Municipal Code.

#### 7.8 CONDITIONS IF WORK IS SUBCONTRACTED

The Proponent assumes full responsibility, including insurance and bonding requirements, for the quality and quantity of all work performed.

If Proponent's supplier(s) and/or subcontractor's involvement requires the use of a licensed, patented, or proprietary process, the proponent of the process is responsible for assuring that the subcontractor, supplier, and/or operator have been properly authorized to use the process or for providing another process which is comparable to that which is required prior to submission of a proposal.

#### 7.9 LICENSING REQUIREMENTS

Any professional certifications or licenses that may be required to perform the scope of work will be the sole cost and responsibility of the successful Proponent.

A City of Stockton Business license may be required for this project. Please contact the City of Stockton Business License Division at (209) 937-8313.

#### 7.10 INDEMNITY AND HOLD HARMLESS

To the fullest extent permitted by law, Contractor shall hold harmless, defend at its own expense, and indemnify the City of Stockton and its officers, employees, agents, and volunteers, against any and all liability, claims, losses, damages, or expenses, including reasonable attorney's fees, arising from all acts or omissions of contractor or its officers, agents, or employees in rendering services under this contract; excluding, however, such liability, claims, losses, damages, or expenses arising from the City of Stockton's sole negligence or willful acts. This obligation is independent of, and shall not in any way be limited by, the minimum Insurance obligations contained in this agreement. These obligations shall survive the completion or termination of this agreement.

#### 7.11 COMPETITIVE PRICING

Proponent warrants and agrees that each of the charges, economic or product terms or warranties granted pursuant to this Contract are comparable to or better than the equivalent charge, economic or product term or warranty being offered to any similarly situated commercial or other government customer of Proponent. If Proponent enters into any arrangements with another customer of Proponent to provide product under more favorable charges, economic or product terms or warranties, Proponent shall immediately notify City of such change and this Contract shall be deemed amended to incorporate the most favorable charges, economic or product terms or warranties.

#### 7.12 AVAILABLE FUNDING

Any contract which results from this RFP will terminate without penalty at the end of the fiscal year in the event funds are not appropriated for the next fiscal year. If funds are appropriated for a portion of the fiscal year, this contract will terminate without penalty, at the end of the term for which funds are appropriated.

### 7.13 TERMINATION FOR CONVENIENCE

The City may terminate the resultant Agreement for convenience at any time by mailing a notice in writing to the Contractor.

### 7.14 AUDITING CHARGES AND SERVICES

The City reserves the right to periodically audit all charges and services made by the successful Proponent to the City for services provided under the contract. Upon request, the Proponent agrees to furnish the City with necessary information and assistance.

### 7.15 CHANGES

The City's Representative has the authority to review and recommend or reject change orders and cost proposals submitted by the Proponent or as recommended by the Proponent's project manager, pursuant to the adopted City of Stockton Standard Specifications.

### 7.16 AWARD

Upon conclusion of the RFP process, a contract may be awarded for Homeless System Support – Staff Augmentation for the City. The City reserves the right to select the successful Proponent and to negotiate terms of a contract with the Proponent whose proposal is most responsive to the needs of the City. Further, the City reserves the right to reject any and all proposals, or alternate proposals, or waive any informality in the proposal as is in the City's best interest.
