PLAYGROUND SITES

PROJECT 1 – Sandman Park | 8801 Don Ave.

BUDGET | \$400,000



SITE DESCRIPTION | Sandman Park is a 16.6-acre community park with an empty round playground site approximately 68 feet across. The park features a group barbecue area, tables, barbecue pits, restroom, basketball, tennis, futsal and handball courts, softball fields, horseshoe courts and a memorial. Playground equipment pictured above has been demolished.

VISION | The goal for the existing play areas is to provide safe and engaging inclusive, all-access play for ages disabled and able-bodied children ages 2-12.

PROJECT 2 Panella Park | 5758 Lorraine Ave.
BUDGET | \$250,000



SITE DESCRIPTION | Panella Park is a 16.9-acre park that is home to the Arnold Rue Community Center. The park includes many amenities, including two lagoons and two play areas, baseball and softball diamonds, restrooms, tennis courts, and picnic shelters. Play components seen above have been demolished.

VISION | The City would like to install two play areas, 2-5 play structure in one and ages 5-12 structure(s) in the other separate bowl. All designs should incorporate all applicable landing and use zones required by California law.

PROJECT 3 - Weber Park | 405 W. Oak St.
BUDGET | \$140,000



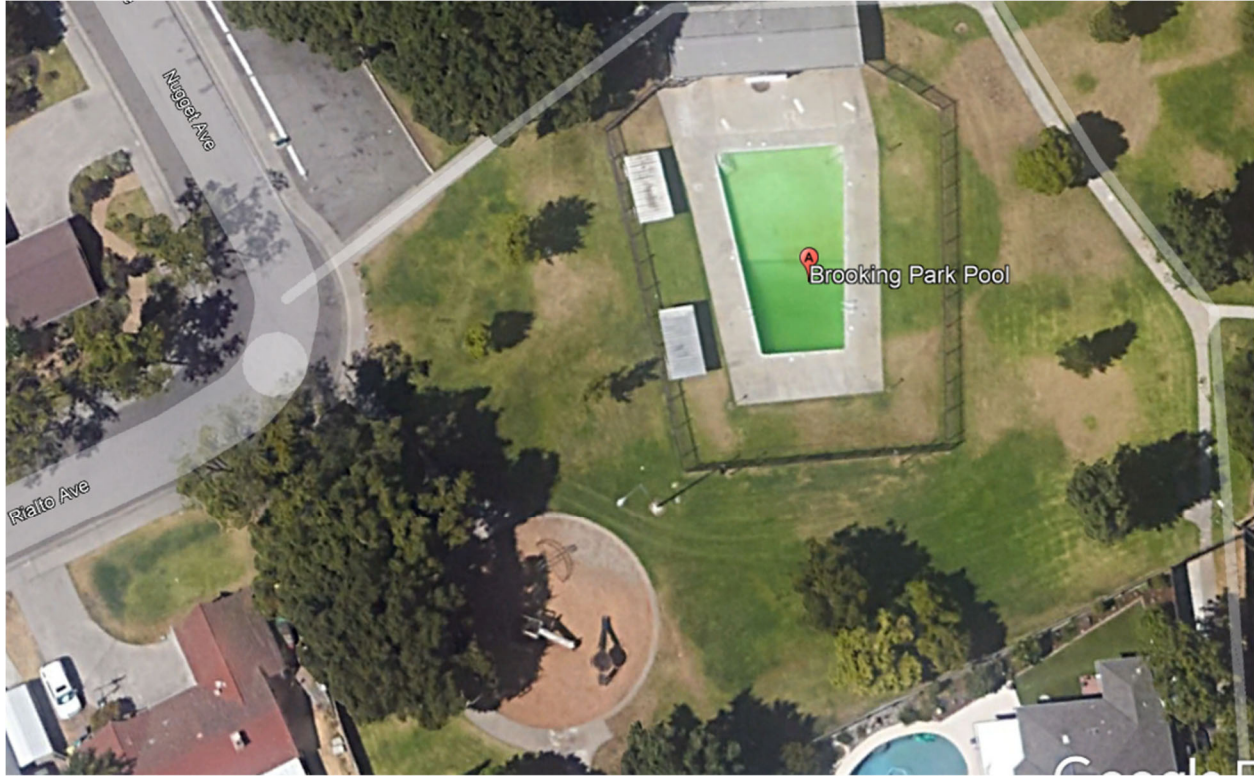
SITE DESCRIPTION | Weber Park is a 2.11-acre public promenade donated to the City in 1851 so it is one of Stockton's original downtown squares. It features a playground bowl that is approximately 55-feet wide. No play structure exists here at this time.

VISION | The City would like to expand active play amenities at this park. The desire is to enhance the existing playground area with a safe and engaging say structure(s) that will serve the recreational needs of children ages 2-12.

PROJECT 4 - Brooking Park | 4500 Nugget Ave.

BUDGET | \$140,000



SITE DESCRIPTION | Brooking Park is a 3.07-acre neighborhood park with a pool, playground, tables, barbecues and a playground bowl that is approximately 55 feet across with existing equipment that must be vacated and demolished.

VISION | The City's vision is to add engaging and safe new play structure(s) for ages 2-12.
