Bid Item #34 - 2" Conform Grind

Measurement

Bid item #34 bid item shall be on a lump sum basis based on the percentage of work completed as determined by the Engineer at the time the progress payment is prepared. Conform grind shall include grinding and replacement of HMA as specified in the plan.

Payment

Bid item #34 shall include full compensation for performing the work specified in Section 19, "Replace Asphalt Concrete Surface", of these special provisions, and include full

compensation for furnishing all labor, materials, equipment and incidentals for doing all the work associated with this item, including, but not limited to: surface preparation, saw cutting or grinding, excavation, removal and disposal of asphalt concrete and/or sub-grade material, disposal of materials with non-recyclable paving fabric (if needed), re-grading, compacting, and scarifying of sub-grade, place asphalt, apply tact coat and/or prime coat (if needed), complete-in-place, as shown on the plans, as specified in these specifications, and as directed by the Engineer, and no additional compensation will be allowed therefore.

4. Page 42: **INCLUDE** base bid item:

5. Page 58, first sentence: **CHANGE** the following:

Where concrete is described to be removed, remove the concrete to a depth of at least 12" below finished grade "Where concrete is described to be removed, remove the concrete up to 12" below finished grade."
