3. Page 3, Section 3.5 "Liquidated Damages"

REVISE the following:

The Contractor shall pay liquidated damages to the City of Stockton in the amount of \$2,400 per day for each and every calendar day that the work remains incomplete after the expiration of the contract ~~ten (10) working days specified in these Special Provisions fifteen (15) working days from the Notice to Proceed.~~ **working days specified in these Special Provisions.**

4. Page 8, Section 5.0 "Quantities"

a. **ADD** the following bid items:

b. **REVISE** the following paragraph:

Each bidder shall bid each item on the **Base Bid Schedule and Alternate Schedules**. Failure to bid an item shall be just cause for considering the bid as non-responsive. **Award of contract, if the City chooses, will be based on the total of the Base Bid items only.** The City reserves the right to include or delete any Schedule or portion thereof, or to reject all bids. All bids submitted for this project must conform to the requirements of the official bid documents.

5. Page 10, Section 7.6 "~~Start of Work~~" **CHANGE** to "**Time of Completion**"

REPLACE with the following paragraph:

The contractor for the performance of the work and the furnishing of materials shall commence within ten (10) days from the Notice to Proceed date and shall be diligently prosecuted to completion before the expiration of the working days specified in this section from the date of said commencement.

The contractor shall diligently prosecute the contract work to completion within fifteen (15) working days.
