Letter of Clarification No. 1 for the above project consists of the following:

SPECIAL PROVISIONS:

2. Page 3, Section 3.5, "Liquidated Damages"

CHANGE the following:

The contractor shall pay liquidated damages to the City of Stockton in the amount of \$2,400 per day for each and every calendar day that the work remains incomplete after the expiration of the contract ~~ten (10) working days specified in these Special Provisions~~ **fifteen (15) working days from the Notice to Proceed.**

3. Page 7, Section 4.6 "Swenson Park Golf Course Fence Replacement"

CHANGE the following:

Chain Link Fence Demo, Removal & Disposal

By linear foot. Includes all labor, materials, tools, equipment and incidentals as indicated on Attachment B – Location Detail for demolishing, removing and disposing of existing ~~chain-link fence, concrete posts and gates~~ **chain link fencing including but not limited to fabric, posts, rails, concrete footings**

and gates. All remaining holes shall be backfilled with clean friable loamy soil and compacted to same density as surrounding undisturbed soil.

4. Note 8 shall be omitted from the base bid. An alternate bid for the concrete mow band will be included in Bid Schedule.
