Includes providing all labor, materials, tools, equipment, to unclog all drain inlets and pipes within parking lot project limits and removing waste materials from the site and performing the work, and incidentals as indicated on the Plans and described in these Special Provisions.

# **REVISE** the following:

- 37.3' Wide Asphalt Rubber Speed Bump
  - a. By the unit. Includes providing all labor, materials, tools, equipment, and incidentals for installing asphalt rubber speed bumps as indicated on the Plans and described in these Special Provisions.
- 5. Page 39, Section 9-1.02, "PAYMENTS"

## **ADD** the following:

- 38.6" Concrete Vertical Curb at Seagull Lane
  - a. By the linear foot. Includes supplying concrete to the site, compacting subgrade and placing aggregate base and constructing to the elevations, thickness, and locations, forming, reinforcing, placing concrete, removing forms, curing, finishing, loading, grading the subgrade in preparation of the finished grade sections, as well as excavating and removing waste materials from the site, and constructing the facilities as indicated on the Plans and described in these Special Provisions.
