- 1. THE NEW START DATE IS DECEMBER 1, 2015.**

- 2. CURRENTLY, THE CITY'S RANDOM POOL SIZE REQUIRES THAT CITY TESTS 11 EMPLOYEES EACH QUARTER (4 OF THESE EMPLOYEES ARE DRUG AND ALCOHOL TESTED). THE RANDOM POOL IS SPLIT BETWEEN TWO DEPARTMENTS. THE CITY ENVISIONS THAT WITH PROPER SCHEDULING, TESTING ONSITE CAN BE ACCOMODATED IN ONE DAY/PARTIAL DAY AT EACH LOCATION, PER QUARTER.**

- 3. AS PART OF THE CONTRACT, THE AWARDED PROPONENT WILL MANAGE THE RANDOM POOL SELECTION.**
