I don't understand what is meant by "package size". Deliveries are roughly between 150 to 250 gallons per load.

4. What is the typical 'order' quantity? Typical order is 150 to 250 gallons.

5. What is the typical 'delivery' quantity?

Deliveries are roughly between 150 to 250 gallons per load.

6. What date and time will the last addenda be issued? We currently do not anticipate any addenda's to be issued.

7. When does this contract start and end? July 1, 2024 to June 30, 2029
